#### 1.1.2 About this Volume

This volume of the User Manual deals only with the instructions and functionality that are specific for the Frequency Analysis module (Frequency Analysis Software BZ 7123).

For information about the general operation and functionality of Mediator please refer to the Basic User Manual (BB 1119).

#### **Conventions Used in this Manual**

#### **Keys**

References to keys on the 2238 Mediator are shown with the key's pictogram as it appears on the instrument (for example  $\stackrel{\leftarrow}{=}$ ). Refer to section 2.1 for a complete list of key pictograms and their functions.

#### **Soft Keys**

Mediator has two "soft keys" that have different functions depending on the current context. The soft keys functions are denoted by chevrons (<>) and courier type face. The current functions of the soft keys are always shown on the display. The soft key can have the following functions: <Select>, <Save>, <Ok>, <Menu> or <Back Erase>. The soft key can have functions: <Cancel>, <Undo> or <Close>. This is similar to the functionality from the familiar Windows® environment.

#### **Parameter Text**

Text which refers directly to text on the instrument's screen or printouts is indicated using a Courier type face.

#### Sockets


Reference to sockets is made in bold type face (for example, **Aux 1**).

#### 1.2 **Serial Frequency Analysis**

#### 1.2.1 What is Serial Frequency Analysis?

A 2238 Mediator with a filter set installed can measure sound levels in nine <sup>1</sup>/<sub>1</sub>-octave bands (from 31.5 Hz to 8 kHz) or 29 <sup>1</sup>/<sub>3</sub>-octave bands (from 20 Hz to 12.5 kHz). A serial frequency analysis is a number of consecutive measurements performed in each of the selected frequency bands. The result is a spectrum measured over some time, the elapsed time or measurement time. During the same period a broadband measurement is performed, see Fig. 1.1.



Time sequence for a measurement consisting of a number of Fig. 1.1 scans. Each scan is a serial frequency analysis which consists of a number (n) of frequency bands. The measurement time required for each frequency band is the sum of the three time intervals:  $T_{Filter}$ ,  $T_{Fast/Slow}$  and  $T_{Dwell}$  (see below)

When making a frequency analysis with Mediator running Frequency Analysis Software BZ 7123, the complete result of a measurement is a spectrum and overall broadband values for the measurement time.

Since a frequency analysis is done by measuring in each frequency band serially (contrary to measuring all bands in parallel), the method is most useful for fairly stationary signals, for example those emitted by rotating machinery. Highly

fluctuating signals, for example from fly-overs and concerts, cannot be measured reliably using serial analysis.

Furthermore, to get a reliable result for a random signal the measurement time in a frequency band depends upon the centre frequency of the band. At high frequencies only a short time is needed, at lower frequencies the measurement time increases. The time that is used for measuring in each band is referred to as dwell time ( $T_{\rm Dwell}$ ). For further information refer to Brüel & Kjær publication: "Frequency Analysis" (BT 0007).

### 1.2.2 Dwell Time

As stated above, the required measurement time varies for different frequencies. If the signal is non-stationary, for example fluctuating in a cyclical manner, even more measurement time may be required to average the fluctuations. Mediator with BZ 7123 offers three ways of controlling frequency analyses:

- Optimized dwell time with three levels of statistical error (or tolerance, see below)
- Fixed, user-selected dwell time
- Averaging of several spectra, with one averaged spectrum as the result

Optimized and fixed dwell times are explained below. Averaging of spectra is explained in section 3.1.5.

### **Optimized Dwell Time**

Dwell times can be optimized in the sense that the reliability or tolerance in all measured frequency bands is the same. This is what Mediator does when you select Optimized dwell time. When Optimized is selected you can choose the required Tolerance (see section 3.1.5). The options are:

• 0.25 dB, 0.5 dB, and 1.0 dB

Choosing, for example,  $0.5\,dB$  tolerance means that there is 67% probability that the measurement results in all selected

bands are within  $0.5\,dB$  for a normally distributed random signal.

It is important to note that the required tolerance influences the total measurement time. For example, scanning all  $^{1}/_{3}$ -octave bands with 0.25 dB tolerance gives a total measurement time of 5 minutes and 50 s – changing the tolerance to 1.0 dB gives 55 s measurement time. Also note that most of the measurement time is spent at low frequencies. The required measurement time can be read directly from the display in the Time Left field in the Working Spectrum Window and the Broadband Measurement Window.

#### **Fixed Dwell Time**

As an alternative to Optimized dwell time, you can select a Fixed dwell time. In this case the same amount of time is used in all  $^{1}/_{1-}$  or  $^{1}/_{3-}$  octave bands. The dwell time can be set in the range from 1 second to 60 minutes (see section 3.1.5).

Using Fixed dwell time is most useful when measuring periodically fluctuating signals. All fluctuations in the signal must be covered during the measurement time.

#### **Total Measurement Time**

The time required to make a frequency analysis is not simply the sum of the dwell times (see Fig. 1.1). For each band to be measured, Mediator must switch on the required octave band filter and ensure that the filter and the detector are settled. The filter transient time is referred to as  $T_{Filter}$  and the time it takes to reset the Fast and Slow time constants is referred to as  $T_{Fast/Slow}$ . The total measurement time is the sum of dwell times and settling times, i.e.,  $T_{Dwell} + T_{Filter} + T_{Fast/Slow}$ . These are shown in Table 1.1.

# 1.4 Frequency Analysis Functions

# 1.4.1 Back-erase

The back-erase function allows you to delete any required number of consecutive frequency bands in a frequency analysis. This is particularly useful if a disrupting noise occurs during a measurement.

## 1.4.2 Aux 1

Aux 1 is set up as an AC Output and cannot be changed.

#### 1.4.3 Aux 2

In addition to the DC Output function in the basic version, **Aux 2** can be set up as a trigger input or a trigger output.

## 1.4.4 Measurement Set-up Menu

The Measurement Set-up menu contains the following items in the Enhanced module:

- Weightings (for selecting  $^{1}/_{1-}$  or  $^{1}/_{3}$ -octave bands, for setting the frequency range and for setting broadband frequency weighting and time weighting)
- Measurement Control (for setting up number of scans, dwell time and Auto Save)
- Correction Filters (for selecting correction filters for sound incidence and windscreen)
- Input/Output (for selecting DC Output, Trigger Input or Trigger Output for the Aux 2 sockets)
- Auto Start (for selecting an Auto Start)
- Save Setup (for saving a measurement set-up)
- Recall Setup (for recalling a measurement set-up)

# 2.1 Key Functions

Each key on Mediator's front panel is marked with a pictogram. This section gives a brief explanation of the keys.

Calibrate A Press this to calibrate Mediator.

System Press this to display the System menu for configuring the instrument and for changing application programs.

Data Files

Press this to select the Data Files menu. The menu options in this window allow you to save and print files and to access the File Manager facility.

Frequency module: If more than one measurement file is recalled, you can use to switch between the recalled files.

Set-up 

Press this to access/step through the set-up options in the Measurement Set-up menu.

Up/Down Arrows ▲ ▼ Press these keys to step up/down in the menu items in the selected window.

**Frequency module:** Use the keys to enter/exit edit mode in the Broadband Measurement Window and to select the parameter field in the Working and Averaged Spectrum Windows.

You can also use these keys to switch between the Averaged Spec-

trum and Broadband Measurement Windows, when recalling measurements.

Left/Right Arrows ◀ ▶ Press these keys to select the parameters in the selected window.

Note: For the sake of consistency the ▲ ▼ keys are always used to select menu items, and the ▲ ▶ keys are always used to select values.

Range □□□ Press this to access the Range Setting menu. Use the ► keys to step through the available measurement ranges or scroll with the □□□ key.

Resets the current measurement data. The Working and Average Spectra are also reset. If a measurement is in progress, it continues immediately after reset. If the instrument is paused, it is still paused after pressing Reset.

Note: If a measurement has been in progress for more than a minute

in progress for more than a minute a warning is displayed and you must confirm the command before any data is deleted.

Meas. Results

Press this in any of the set-up menus to return to one of the Measurement Windows. If menu changes have not been saved, they are cancelled.

Reset

		Frequency module: Use this key to switch between the Broadband Measurement Window and the Working and Average Spectrum Windows.
Pause/Continue	1/,	Press this to pause/continue the current measurement. When resuming a measurement after pausing Mediator, the measurement is continued without resetting data or the timer. # 3.1 Measurement Set-up Menu

#### 3.1.1 Introduction

This chapter explains how to set up measurement parameters that are specific for the Frequency Analysis module.

## 3.1.2 Measurement Set-up Menu




Fig. 3.1 The Measurement Set-up menu (two windows)

Frequency Analysis Software BZ 7123 contains the menu items shown in Fig. 3.1.

## **3.1.3** Range

There is no General Window in the Frequency Analysis module, this means that the Range Setting menu must be accessed by pressing the  $\square$  Range key.

# 3.1.4 Setting Frequency Weightings




Fig. 3.2 The Weightings Window

The Weightings Window is used for setting up frequency and time weightings for octave and broadband data, see Fig. 3.2.

Note that  $^{1}/_{1}$ - and  $^{1}/_{3}$ -octaves are always measured with detector 1 and broadband data is measured with detector 2. Time weighting settings apply to both detectors.

#### **Setting Bandwidth**

- 1/3-octave
- 1/1-octave

Select the desired option in the Bandwidth field.

**Note**: To run Frequency Analysis Software BZ 7123 the <sup>1</sup>/<sub>1</sub>-octave and <sup>1</sup>/<sub>3</sub>-octave Filter Set must be installed in Mediator.

#### **Setting Frequency Limits for Octave Bands**

For setting the frequency range for the frequency analysis. The Limits parameter field automatically changes to  $^{1}/_{1}$ - or  $^{1}/_{3}$ -octave frequency steps according to the Bandwidth field above. The default values are:

- 31.5 Hz 8 kHz ( $^{1}$ /<sub>1</sub>-octave)
- $20 \,\text{Hz} 12.5 \,\text{kHz}$  (1/3-octave)

Use the  $\blacktriangle$  variable cursor keys to select the lower or upper frequency fields and set the desired range with the  $\blacktriangleleft$  variable cursor keys. If you change the Bandwidth setting, Mediator remembers the corresponding Limits setting.

**Note:** The lower frequency must always be lower than or equal to the upper limit. The upper or lower limits are automatically adjusted to fulfil this requirement. Setting the upper and lower limits to the same value is equivalent to selecting a single frequency band with that centre frequency.

### **Setting Frequency Weighting for Broadband Data**

• A, C, L

#### **Measurement Set-up Menu**

In the Broadband Wgt. field you can select A, C or L frequency weighting. This frequency weighting only applies to the broadband data.

#### **Setting the Time Weighting**

• F, S

The Time Weighting field is used to set the time weighting used for both octave and broadband data. You can select the standardised F and S time weightings.

#### 3.1.5 Measurement Control




Fig. 3.3 The Measurement Control Window

The Meas. Control Window, see Fig. 3.3, is used to set up the parameters that affect the accuracy of a frequency analysis and whether a measurement is saved automatically or not.

### **Setting the Number of Scans**

No. of Scans allows you to set up the desired number of frequency scans from 1 to 99. This is the number of averages that is used to display the result in the Average Spectrum Window. As a general rule frequency analysis should be performed on stationary signals. However, with appropriate averaging a good representation can be made for a number of non-stationary signals.

### **Setting the Dwell Time**

Dwell Time is used for setting the measurement time for each frequency band  $(T_{Dwell})$  in the frequency analysis.

- Optimized
- Fixed

When Optimized is selected Mediator automatically calculates the optimum measurement time ( $T_{Dwell}$ ), based on the current frequency band and the specified measurement tolerance (see Tolerance below). Refer to section xx for information about filter characteristics and calculation of measurement time. For normal frequency analysis you should select Optimized.

#### **Setting Tolerance/Time**

Depending on whether Optimized or Fixed is selected in the Dwell Time parameter field, this parameter field appears as Tolerance or Time respectively.

#### **Tolerance**

• 0.25, 0.5, 1.0dB

Specifies the measurement tolerance when Optimized is selected. Lower tolerance (higher accuracy) increases the measurement time.

#### **Fixed**

• 00:01 ... 60:00

Fixed allows you to specify a measurement time  $(T_{Dwell})$  which is always constant, irrespective of frequency band and octave bandwidth (see Time below).

Use the ▲ ▼ cursor keys to select the minute or second fields and set the desired time with the ◀ ▶ cursor keys. The Fixed time can be set from 1 second to 60 minutes.

### **Setting up Auto Save**

- On
- Off

The Auto Save function can be switched on or off. When activated it will automatically save a measurement when it is finished, i.e. when the specified number of scans is com-

pleted. A measurement is not saved when the pause function is activated. Measurements are stored with consecutive numbers in the File List.

# 3.1.6 Setting up the Input/Output Function




Fig. 3.4 The Input/Output Window

The Input/Output Window controls the function of the Aux 1 and Aux 2 inputs/outputs. See Fig. 3.4.

#### Aux 1

The  $\text{Aux}\,1$  field is set to AC Output and cannot be accessed. The AC output signal is fed to the  $\text{Aux}\,1$  socket. The AC output corresponds to the constant output from the scanned octave bands, with filter transients.

Full-scale indication corresponds to 1 V RMS. This output signal can be used, for example, for recording the measured signal on a DAT recorder.

#### Aux 2

- DC Output
- Trigger Input
- Trigger Output

DC Output supplies a DC output signal equivalent to the AC output signal. Full-scale indication corresponds to  $4.0\,\mathrm{V\,DC}$  (50 mV/dB).

Trigger Input starts a measurement when an external trigger voltage is applied. The trigger level is 2V (refer to

Specifications). A trigger is ignored if Mediator is not paused and displays one of the Measurement Windows.

Trigger Output supplies a status voltage that is high (>4 V DC) when a measurement is proceeding or low (0 V) when the instrument is paused. The Trigger Out signal can be used to start/stop external equipment such as tape and level recorders.




Fig. 4.1 The Working Spectrum Window, the Averaged Spectrum Window and the Broadband Measurement Window, shown in that order

Three different measurement result windows are used for the frequency analysis module: Working Spectrum Window, Averaged Spectrum Window and Broadband Measurement Window. The result windows are illustrated in Fig. 4.1. Use the Meas. Results key to change between the windows in the mentioned order.

# 4.1.1 Working and Averaged Spectrum Windows

The Frequency Analysis module has two spectrum displays. The Working Spectrum Window shows the results so far of the current scan of the frequency bands, i.e., it reflects the currently ongoing measurement. The Average Spectrum Window shows the cumulative results of the selected number of scans.

The result of a measurement is what is in the Averaged Spectrum. This spectrum is updated whenever a scan of the frequency bands is completed; if more than one scan is performed, each new complete scan is averaged with the current contents of the Averaged Spectrum. When only a single scan

**User Manual** 

is performed, the result of this scan is also transferred to the Averaged Spectrum.

Example: If you select five scans of the 29 <sup>1</sup>/<sub>3</sub>-octave bands and start the measurement, you will see the Working Spectrum being updated as the frequency bands are measured. The Averaged Spectrum has no content until the first scan of all 29 bands is completed. At that time it is updated with the results of the first scan and shows that this is result 1 out of 5 scans (Scan No. 1/5). When scan no. 2 starts, the Working Spectrum is cleared and shows the results of the second scan as the frequency bands are available. Next update of the Averaged Spectrum is when the second scan is complete, and so on until all five scans are completed. At this time the Averaged Spectrum shows the result of five averaged spectra, and the Working Spectrum shows the result of the last scan (scan no. 5). If the measurement is saved, automatically or manually, it is the Averaged Spectrum that is saved.

If you select, for example, 10 scans and choose to stop the measurement after three scans by pausing the measurement in the middle of the fourth scan, the Averaged Spectrum is the result of the three completed scans, i.e., you always save the result of completed scans and any half-finished scan (in this example the fourth scan) is not saved. The only exception is when the first scan is not finished. In this case it is possible to save the finished frequency bands (after a warning that the scan is incomplete). The saved frequency bands are also shown in the Averaged Spectrum. After saving an incomplete scan, the measurement can be continued.

# **Display Layout**

The two spectrum windows are fairly similar. The upper parameter line (Time Left) in the Working Spectrum Window shows the total/remaining measurement time. In the Averaged Spectrum window this field is replaced with a Scan No. line which shows the current/total number of scans.

**Note:** Measurement times higher than 1000 hours are displayed as: ---:-- in the Time Left fields in the Broadband Measurement and Working Spectrum Windows.

The second parameter line in both windows show the current spectrum parameter and the frequency/measurement value which the cursor points at or which is being measured.

#### 4.1.2 Broadband Measurement Window

The Broadband Measurement Window is similar to the Measurement Window in the Basic module. In the four parameter fields you can select between the parameters available in the Frequency Analysis module:

• L<sub>XYinst</sub>, L<sub>XYp</sub>, L<sub>Xeq</sub>, L<sub>XYMax</sub>, L<sub>XYMin</sub>, Overload%, Underrange%, Time Left, Start Date, Start Time, Elapsed Time, Time, Scan No.

# 4.1.3 Selecting Spectrum Parameter for Display

During measurement or when a measurement is finished you can change the displayed spectrum parameter in the Working and Averaged Spectrum Windows. You can select the following spectrum parameters:

•  $L_{Xeq}$ ,  $L_{XYMin}$  or  $L_{YMax}$ 




Fig. 4.2 The Spectrum Parameter field (highlighted)

- Use the ▲ or ▼ keys to select the Spectrum Parameter field.
- 2. Use the **→** keys to select the spectrum parameter. The display changes accordingly.

## 4.1.4 Using the Spectrum Cursor

When a measurement is finished you can use the keys to step the cursor through the measured frequency bands in the Working and Averaged Spectrum Windows. The frequency and associated measurement value can be seen in the parameter line. ▶

#### 4.1.5 Overloads

Instantaneous and latched overloads are displayed in the Broadband Measurement Window in the same way as in the Measurement Window in the Basic module.

In the Working and Averaged Spectrum Windows the overload indications are shown to the right of the spectrum display. The latched overload indicates that an overload occurred in one or more of the frequency bands during measurement. In the Averaged Spectrum Window the latched overload may have occurred in any of the scans, if a number of scans were selected.

**Note:** Overloads in the spectrum windows are only detected during the measurement periods  $(T_{Dwell})$ , i.e., no overloads are detected during the filter and detector settling periods.

## 4.1.6 Pausing/Interrupting a Measurement

In the Working Spectrum and Broadband Measurement Windows you can use the 'k' key to pause/continue an ongoing measurement. When resuming a measurement after pausing Mediator, the measurement is continued without resetting data. Pressing this key after a measurement is finished performs a reset and starts a new measurement.

If the Working Spectrum Window is displayed and you press the "key during a measurement, the Back Erase mode is activated (see Erasing Bad Data below).

#### 4.1.7 Instantaneous Value

A separate column on the right hand side of the spectrum display shows the instantaneous value ( $L_{XYInst}$ ) of the RMS level and is updated five times per second. The associated frequency weighting is shown in the lower right-hand corner of the display.

# 4.2 Erasing Bad Data

The back-erase function allows you to delete any number of frequency bands in the current scan. This is particularly useful for deleting a non-typical noise occurrence during a measurement.

- 1. Use the \*\frac{1}{2} key to display the Working Spectrum Window during a measurement.
- 2. Press the "% Pause/Continue key. The Time Left line is replaced with a <Back Erase> soft key.




Fig. 4.3 The Back Erase function

- 3. Use the **→** cursor keys to move the spectrum cursor to the frequency band to which you want to delete the frequency bands.

You can continue the measurement by pressing the "% Pause/Continue key. The Time Left field is updated to show the actual remaining measurement time.

**Note:** If you do not back-erase any frequency bands, the measurement will continue from the frequency band where it was paused.

# 4.3 Setting a Measurement to Start Automatically

Mediator can manage up to four auto starts. Auto Starts are shared among the application modules that support them. Each Auto Start has a number (1 through 4) and is set to start a specific application at a specified time (up to one month ahead) using a specified set-up. See also section 3.1.5 in the Basic User Manual.

From a specific software module, in this case Frequency Analysis Software BZ 7123, all four Auto Starts can be seen and selected, but you can only set up an Auto Start for the currently running application module. If you want another application module to start, the Auto Start must be set from that module.

### To set up an Auto Start:

Select Auto Start from the Measurement Set-up menu.
 If no Auto Start is set up, for example for Auto Start no.
 the display appears as:




Fig. 4.4 The basic Auto Start Window

2. Use the 

cursor keys to select one of the four Auto Starts and press <0k>.

If the Auto Start is active, the display will show the associated application module as well as the set-up number and the start time.



Fig. 4.5 Auto Start set-up

Use the ▲ ▼ cursor keys to select the Application field, and use the ◀ ► cursor keys to select None or BZ7123. None means that the Auto Start is not active (if previously set, the set-up parameters will be deleted if you press Ok). If the Auto Start is already activated by another application module (for example BZ7124), the number of this application module is also among the choices. The display will appear similar to Fig. 4.5.

- Set up the Date, Time and Use Setup no. fields as required. The date and time can be set to one month ahead.
- 4. Press Ok to activate the Auto Start.




Fig. 4.6 Confirmation of an Auto Start when switching Mediator off

When switching Mediator off, the message shown in Fig. 4.6 is displayed.

**Notes**: An Auto Start only takes effect if Mediator is switched off at the time the Auto Start is supposed to run. If Mediator is already switched on, the Auto Start is cancelled.

Mediator keeps measuring until the selected number of scans are finished or until manually stopped.

Mediator switches on approximately 30 s before the set time for an Auto Start. This allows Mediator to settle and start measuring at exactly the set time.

## 5.1 Data Storage

#### 5.1.1 Saved Data

A measurement data file contains both overall measurement data and spectrum measurement results. It consists of a group of set-up data and a group of associated measurement data. The set-up data are:

- Serial number for Mediator unit
- Measurement set-up
- Calibration data

Measurement data are:

- Overall results
- Broadband measurement results
- Spectrum measurement results (1/3- or 1/1-octave)

## 5.1.2 Set-up Data

All measurement set-up parameters that were used for the measurement.

- Sensitivity
- Calibration date

### 5.1.3 Measurement Data

#### **Spectrum Measurement Results**

The following data are always saved for each frequency in the  $^{1}/_{3}$ - or  $^{1}/_{1}$ -octave frequency bands. Only the bands within the measured frequency range are saved:

- L<sub>eq</sub>, L<sub>Max</sub>, L<sub>Min</sub>
- Marks (Overload, Underrange)

In printouts overloads are marked as  $\circ$  and underrange as  $\circ$  . If an underrange occurs in a frequency band, the associated value field appears as: ---.

If the first scan is saved without completing all frequency bands, the value fields for the missing bands appear as:  $\mathbb{N}$ .  $\mathbb{A}$ .

## 5.2 Store Files

### **Automatically Saved Files**

If the Auto Save function in the Meas. Control Window is switched on, measurements are stored automatically with consecutive numbers.

## **How to Store the Current Measurement Manually**

- 1. Press the Data Files key to display the Data Files menu.
- 2. Press the □ Data Files key, the □ <Select> softkey or the ► cursor key or to store the measurement with

#### File Manager

the displayed file name. "Saving File ..." is displayed while saving takes place.

#### **Single Scan**

If a single scan is selected you can store the frequency bands that have been completed:

- 1. Press the " Pause/Continue key to pause the measurement.
- 2. Store the measurement as described above.

#### **Multiple Scans**

If more than one scan is selected, only the complete scans are stored. The stored scan is identical to the scan shown in the Averaged Spectrum Window.

## 5.3 File Manager

The File Manager is used to give an overview of the data files in the memory and has options for recalling, printing and deleting these files. The Disk Summary option shows the memory status. Refer to the Basic User Manual for information about how to use the File Manager

## 5.4 Printing Data

Printing is similar to the Basic module, the main difference is that the Print Options menu does not exist, i.e., all setup and measurement parameters are printed.

## 5.5 Displaying Stored Files




Fig. 5.1 The Recall Average Spectrum and the Recall Broadband Measurement Windows (separate windows)

If a stored file has been recalled from the File Manager the data is displayed in two recall windows as illustrated in Fig. 5.1

Except for the instantaneous parameters and overload indication these windows are similar to the Average Spectrum Window and the Broadband Measurement Window.

## **5.5.1 Switching Between the Recall Windows**

Use the ▲ key to switch between the Recall Average Spectrum and Recall Broadband Measurement Windows.

**Note:** Both  $\bigvee$   $\blacktriangle$  keys switch between the windows when they reach the top or bottom of the current window.

Use the Meas. Results key to return to the measurement window which was active when you recalled the stored files.

## 5.5.2 Switching Between Recalled Files

Use the Data Files key to step through the files, if more than one file has been selected in the File Manager.

If the cursor is positioned in the Print/Cancel fields in the Recall Broadband Window, you can also use the ◀ ▶ keys to step down/up through the file list.

## **5.5.3 Selecting Parameters and Frequency Bands**

#### **Parameters**

In the Broadband Measurement Windows you can use the 
▼ ▲ and ◀ ▶ keys to select one of the four parameter lines and change the parameters, exactly as in the Broadband Measurement Window

#### **Frequency Bands**

In the Recall Average Spectrum Window you can use the 

★ keys to step the cursor through the frequency bands when the Print/Cancel fields are highlighted.

If you select the Parameter Field, you can use the  $\triangleleft$   $\blacktriangleright$  keys to display the  $L_{eq}$ ,  $L_{Ymin}$  or  $L_{Ymax}$  spectra as required.




Fig. 8.1 Syntax for the Average? query and Mediator response




Fig. 8.2 Syntax for the PArameter? query and Mediator response




Fig. 8.3 Syntax for the SEtup command




Fig. 8.4 Syntax for the SEtup? query and Mediator response




Fig. 8.5 Syntax for the Working? query and Mediator response
